**COUNCIL IMPLEMENTING REGULATION (EU) 2026/1394**

**of 22 June 2026**

**implementing Regulation (EU) 2023/2147 concerning restrictive measures in view of activities undermining the stability and political transition of Sudan**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EU) 2023/2147 of 9 October 2023 concerning restrictive measures in view of activities undermining the stability and political transition of Sudan <sup>(1)</sup>, and in particular Article 13 thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 9 October 2023, the Council adopted Regulation (EU) 2023/2147.
- (2) On 28 April 2026, the United Nations Security Council (UNSC) Committee established pursuant to UNSC Resolution 1591(2005) added four persons to the list of persons subject to restrictive measures.
- (3) On 7 May 2026, the Council adopted Implementing Regulation (EU) 2026/1051 <sup>(2)</sup> adding three of those four persons to the list of natural and legal persons, entities and bodies set out in Annex I to Council Regulation (EU) No 747/2014 <sup>(3)</sup>.
- (4) On 22 June 2026, the Council adopted Implementing Regulation (EU) 2026/1393 <sup>(4)</sup> adding the fourth person to the list of natural and legal persons, entities and bodies set out in Annex I to Regulation (EU) No 747/2014.
- (5) The entry for that fourth person should therefore be deleted from the list of natural and legal persons, entities and bodies set out in Annex I to Regulation (EU) 2023/2147.
- (6) Regulation (EU) 2023/2147 should therefore be amended accordingly,

HAS ADOPTED THIS REGULATION:

*Article 1*

In Annex I to Regulation (EU) 2023/2147, under the heading 'A. Natural Persons', the following entry is deleted:

'14. Algony Hamdan DAGALO MUSA'.
